We own or control the mechanical recording rights in the copyrighted musical work(s) referred to on page 1 hereof (hereinafter referred to as the "Composition(s)"). You have advised us that you wish to obtain a compulsory license to make and to distribute phonorecords of the copyrighted work referred to in (A) supra, under the compulsory license provision of Section 115 of the Copyright Act.

Upon your doing so, you shall have all the rights which are granted to, and all the obligations which are imposed upon, users of said copyrighted work under the compulsory license provision of the Copyright Act, after phonorecords of the copyrighted work have been distributed to the public in the United States under the authority of the copyright owner by another person, except that with respect to phonorecords thereof made and distributed hereunder:

1. You shall pay royalties and shall render detailed accounting statements required by the Copyright Act, except that they need not be rendered under oath and they need only be rendered to us quarterly, within forty-five (45) days after the end of each calendar quarter, on the basis of phonorecords made and distributed.
2. For such phonorecords made and distributed, the royalty shall be the full statutory rate in effect at the time the phonorecord is made.
3. This compulsory license covers and is limited to one particular recording of the Composition(s) as performed by the artist and on the phonorecord number identified in (C) supra and this compulsory license does not supersede nor in any way affect any prior agreements now in effect respecting phonorecords of said Composition(s). We reserve all rights not expressly granted under this license. Any use of the Composition(s) and any manufacture, distribution or sale of the recording outside the terms of this license shall be actionable as acts of copyright infringement in the Composition(s).
4. This variance is specifically limited to the use of the Composition(s) and the sale of the recording only within the United States of America, its territories and possessions unless we grant you written permission to the contrary.
5. In the event you fail to account to us and pay royalties as herein provided for or breach any of the other terms hereof, then in addition to our other rights and remedies, we or our agent may give written notice to you that, unless the default is remedied within thirty (30) days from the date of the notice, this compulsory license will automatically terminate. Such termination shall render either the making or the distribution, or both, of all phonorecords for which royalties have not been paid, actionable as acts of infringement under, and fully subject to the remedies provided by the Copyright Act. A waiver of any breach by you hereunder shall not constitute a waiver of any succeeding breach whether similar or dissimilar.
6. We or our representative shall have the right to examine, inspect and make extracts of your books and records as same pertain to the Composition(s), provided that such examination and inspection shall take place upon twenty (20) days prior notice to you.
7. You will not use or authorize the use of the title of any of the Composition(s) in any manner whatsoever on the label, cover, sleeve, jacket, box or other packaging in which the phonorecord is sold, except in a list of musical compositions contained thereon and then only in print of size, type and prominence no greater than that used for the other musical compositions contained thereon.
8. On the label affixed to each phonorecord manufactured by you, with respect to each of the Composition(s) embodied thereon, you will include the title of the Composition(s), our name as publisher, the name of the performing rights society with which we are affiliated and the last name of the composer(s) and lyricist(s).
9. You need not serve or file a notice of intention to obtain a compulsory license required by the Copyright Act.
10. Additional provisions are reproduced under (D) supra.
